

# Camp Reservation Form

## Fee Schedule

The Missouri River Christian Camp is operated by the Rocky Mountain Christian Institute. The Camp was built and is maintained through voluntary contributions. The Board of Directors of RMCI suggests the following Contribution Fee Schedule for use of the camp:

### Overnight Fees:

Fellowship Hall Sleeping Rooms (6 rooms*) .....	\$ 30.00 per night / room
Garage Loft (sleeps 8) .....	\$ 45.00 per night
Bunkhouse Room (sleeps 13) .....	\$ 60.00 per night
RV Spaces .....	\$ 25.00 per night / space
Camping in Tent.....	\$ 15.00 per night / tent

\* 5 rooms have one queen bed and one set of bunk beds and one room has one queen bed. There are a total of six rooms.

### Day Use Fees:

Adults ,..... \$ 5.00 per day/per person  
Children .... \$ 2.50 per day/per person

The camp reservation form must be completed before the camp will be reserved for the applicant. A non refundable reservation fee of \$50 must accompany the form when reserving three or more rooms. Fees include cleaning at the end of stay. All fees must be paid to the camp host at checkout time.
